

Directions to the Courthouse and Mound St. During Construction

Going to the Courthouse

From the North

GO SOUTH ON I-71

Exit at Spring Street/Exit 109B (on the right). Turn right on to Spring Street to Third Street. Turn left on to Third Street to Fulton Street. Turn right on to Fulton Street. Take Fulton Street to the Franklin County parking garage mid-block on the right.

DRIVING SOUTH ON 315

Take 315 south to the Rich/Town exit ramp. Turn left on to Rich Street to Main Street. Turn right on to Third Street to Fulton Street. Turn right on to Fulton Street. Take Fulton Street to the Franklin County parking garage mid-block on the right.

or

Take 315 south to 670 east. Take the 670 east/Neil Avenue exit ramp. Turn right on to Neil Avenue to Long Street. Turn left on to Long Street to Third Street. Turn right on to Third Street to Fulton Street. Turn right on to Fulton Street. Take Fulton Street to the Franklin County parking garage mid-block on the right.

DRIVING FROM THE NORTHEAST ON I-670

Take I-670 west to the High Street/Third Street/Exit 4B. Follow the Third Street ramp. Continue on Third Street to Mound Street. Turn right on to Mound Street. Go past St. John's Church and turn left into the Franklin County parking garage. While traffic is open during construction on Mound Street, an alternate route is continue on Third Street one more block past Mound Street to Fulton Street. Turn right on to Fulton Street. Take Fulton Street to the Franklin County parking garage mid-block on the right.

From the South and the West

DRIVE NORTH ON I-71/EAST ON I-70

Exit at the Front Street /High Street/Exit 100A. Turn left on to Front Street. Turn left into the Juvenile Detention Center parking garage mid-block after turning on to Front Street.

From the East

GO WEST ON I-70

Exit at Downtown/Exit 101B. This ramp becomes Mound Street. Go past St. John's Church and turn left into the Franklin County parking garage. While traffic is open during construction on Mound Street, an alternate route is to turn left on to Third Street. Turn right on to Fulton Street. Take Fulton Street to the Franklin County parking garage mid-block on the right.

LEAVING THE COURTHOUSE:

To Go North VIA ROUTE 315

Take Mound Street to Front Street. Turn right onto Front Street. Turn left on to Spring Street. Turn right on to Neil Avenue. Turn left on to Goodale Boulevard. Turn right on to 315 north.

Going North VIA I-71

Take Mound Street to High Street. Turn right on to High Street. Turn right on to Main Street. Turn right on to I-71.

or

Take Mound Street to High Street. Turn right on to High Street. Turn right on to Main Street. Turn left on to Fourth Street. Take Fourth Street to I-670 east to I-71 north.

To Go South VIA I-71

Take Mound Street to High Street. Turn right on to High Street to Main Street. Turn right on to Main Street to Third Street. Turn right on to Third Street to I-71 south.

To Go West VIA I-70

Take Mound Street to the I-70 west ramp. Turn left on to I-70 west.

To Go East VIA I-70

Take Mound Street to High Street. Turn right on to High Street to Main Street. Turn right on to Main Street to Third Street. Turn right on to Third Street to I-70 east.
